Question 1 [12 marks]

Consider a network with the following components:

- Two IEEE 802.11g wireless LAN basic service sets; each BSS containing two clients. Refer to the clients as Laptop1, Laptop2, Laptop3 and Laptop4.
- The BSS's are connected via a 100Mb/s Fast Ethernet switched LAN. The Fast Ethernet switch (Switch1) is also connected to a 1Gb/s Ethernet switch (Switch3).
- Three PC's (PC1, PC2, PC3) attached to a 100Mb/s Fast Ethernet switch (Switch2). The switch is also connected to the 1Gb/s Ethernet switch Switch3.
- Switch3 is connected to a router (R1) which has two additional interfaces: an 8Mb/s PDH E2 link to an ISP's router (R2); and a 34Mb/s WiMax link to a router at another campus (R3).
- \bullet Both routers R2 and R3 are part of separate core networks that connect to the Internet.
- (a) Draw the network topology, naming all network devices (using the names mentioned above and/or other meaningful names, such as AP1) and naming all links (based on the link technology, e.g. WiMax). [4 marks]

In answering the following questions about addresses, use the following notation for your answers:

- MAC (or hardware) address of device: *MAC(devicename)* e.g. MAC(Laptop1)
- IP address of device: *IP*(*devicename*) e.g. **IP**(Laptop1)
- (b) If Laptop1 is downloading a file from PC1 using TCP, what addresses are inside the header of a IEEE 802.11 data frame received by Laptop1? [2 marks]

(c) If Laptop2 in one BSS is sending data to Laptop3 in the other BSS, what addresses are inside the header of the IEEE 802.11 data frame sent by Laptop2? [2 marks]

Draw the protocol stack of the following devices from the above network, clearly labelling the protocols/technologies used at each layer (assume hosts run a 5 layer Internet stack; if the question does not indicate a specific protocol, then give the layer name or example protocol):

(d) A wireless LAN AP [2 marks]

(e) Router R1 [2 marks]

- (a) List the following in ascending order of size (from smallest to biggest): MAN, BAN, WAN, LAN. [1 mark]
- (b) List two advantages of wireless networks compared to wired networks. [1 mark]

(c) List two disadvantages of wireless networks compared to wired networks. [1 mark]

(d) Explain the difference between an access network and a core network. [1 mark]

(e) Explain an advantage of using ADSL for home internet access compared to coaxial cable. [1 mark]

(f) Which technology typically provides the lowest data rate: WiFi, WiMax, HSPA, Bluetooth, ZigBee? [1 mark]

(g) Which technology typically provides the highest download data rate: GPRS, LTE, HSPA, EDGE, CSD? [1 mark]

(h) Explain two reasons why, when selecting a wireless technology, considering the frequency/bandwidth the technology uses is important. [2 marks]

Question 3 [8 marks]

(a) Draw a diagram that shows the exchange of frames for the client to actively discover a wireless LAN access point and join that AP's network. Label each frame with its name. [3 marks]

(b) Explain how passive discovery works in wireless LANs, including the frame types used. [1 mark]

- (c) What is the name (or acronym) for the network identifier that is common across all wireless LAN APs in the same network? [1 mark]
- (d) What is the most common frequency used by wireless LANs? [1 mark]
- (e) What is the name of the firmware running on the wireless routers for your assignment? [1 mark]
- (f) What is the maximum wireless LAN data rate supported by the wireless routers for your assignment? [1 mark]

Question 4 [12 marks]

(a) Explain the difference between a transit agreement and a peering agreement between ISPs. [2 marks]

(b) With respect to the transit and peering agreements made between ISPs, explain the difference between a Tier 1 ISP and a Tier 2 ISP. [2 marks]

(c) Explain the difference between public peering and private peering. [2 marks]

(d) Explain the difference between an interior and exterior gateway (or routing) protocol. [2 marks]

(e) Which of the following organisations/networks are most likely to have an AS Number? Thammasat University's network, SIIT School of ICT's network, Steve's home network, TOT's network, Google's network (List the organisations; there may be multiple) [1 mark] (f) Draw a diagram of an internet that shows the following:

- 3 autonomous systems connected via 2 routers; each of these routers have two interfaces
- Each AS has 2 subnets
- Routers should be drawn as circles
- Networks should be drawn as clouds (or ellipses)
- Label each AS and subnet with a name, e.g. "AS1", "SN2"

There may be multiple ways to draw the network. [3 marks]

Question 5 [19 marks]

Some of the following questions require you to draw a timing diagram to illustrate the steps of the IEEE 802.11 DCF protocol. You must label the frames and different time periods with appropriate names (e.g. SIFS, Backoff, Defer, ACK). The exact times and scale are not important, just the ordering of the steps. Unless otherwise stated, assume all stations are within transmission range of each other.

(a) Draw a timing diagram that illustrates the normal procedure (no errors, no deference, no collisions) for the IEEE 802.11 DCF Basic access protocol when station A has data to send to station B. No other stations are present. [3 marks]

(b) Draw a diagram as in part (a), but when RTS/CTS is used instead of Basic Access. [3 marks]

(c) Assume there are 4 stations, A, B, C and D. Station D has just completed a data transfer to C. That is, C has just responded to D with an ACK frame. Both A and B had data to send to C during the data transfer from D to C, but both A and B deferred until the ACK from C to D was completed. Assuming A chooses a smaller random integer than B, draw a timing diagram showing the data transfer from A and B to C, starting from immediately after the initial ACK from C to D. That is, you don't need to draw the data transfer from D to C, only from A to C and B to C. Basic access is used. [3 marks]

(d) What would happen if in part (c), both A and B chose the same random integer? [1 mark]

(e) DCF uses a Contention Window, CW. Its initial value is set to CWmin, which is defined for each IEEE 802.11 physical layer. The value of CW changes when a station must retransmit frames. Explain how CW changes for each retransmission. [1 mark]

- (f) Explain an advantage of this change of CW for a retransmission. [1 mark]
- (g) Explain a disadvantage of this change of CW for a retransmission. [1 mark]
- (h) Explain the hidden terminal problem, e.g. what causes it and what happens in DCF. [2 marks]

- (i) RTS/CTS can be used to reduce the impact of the hidden terminal problem. What information is contained in the RTS (and CTS) frame that is used to reduce the impact of the hidden terminal problem? [1 mark]
- (j) If a station, which is not the destination of a CTS, receives a CTS frame, what does that station do? [1 mark]

(k) Explain how a station chooses whether to use Basic Access or RTS/CTS. [2 marks]
